## Station Policy Statement

### KLRU Diversity Policy

KLRU will seek diversity and excellence in its people, ideas, programs and services by seeking candidates for our Board of Directors, Community Advisory Board, staff and management who embrace the broad values fostered by diversity. Though its goals, policies, management and oversight boards, KLRU will strive to create and maintain a diverse culture based on inclusion and not just representation. KLRU shall be an equal employment opportunity employer and will strive to recruit a diverse workforce, Community Advisory Board and Board of Directors from a diverse pool.

To further this policy, the Board of Directors shall insure the following are completed annually:

- 1) A review of those practices that are designed to fulfill the station's commitment to diversity and to meet the applicable FCC guidelines.
- 2) Provide an annual report of the KLRU recruiting and hiring goals as required by federal law and the Corporation for Public Broadcasting's polices and guidelines. These reports will be posted on the station's website.
- 3) A formal diversity training program for management and appropriate staff.
- 4) Additionally, it is our policy that at least one of the following actions must be completed on an annual basis:
  - a) Include individuals representing diverse groups in internships or work-study programs designed to provide meaningful professional level experience in order to reflect the diversity of the community and further public broadcasting's commitment to education
  - b) Seek a diverse slate of candidates for nomination to the KLRU Board of Directors and Community Advisory Board.
  - c) Implement a diversity training program for members of the organization's governing board of directors on an annual basis
  - d) Participate in minority or other diversity job fairs
- 5) KLRU will also:
  - a) Widely disseminate all full-time job postings to actively seek diverse candidates.
  - b) Make an effort to ensure that the recruitment process for any open senior management position has a diverse pool of candidates.
  - c) Provide volunteer and/or internship opportunities to students that represent diverse groups.
  - d) Post all full-time job openings electronically.
  - e) Maintain nondiscrimination and harassment policies.
  - f) Review all KLRU policies with new employees.
  - g) Have open communications.
  - h) Annually review at a Board meeting those practices that are designed to fulfill the stations commitment to diversity and to meet the applicable FCCvguidelines.
- 6) The Board Affairs Committee shall report annually on the accomplishment of these actions, generally at the last meeting of the fiscal year.

FORMAL APPROVAL: The KLRU Diversity Policy was approved by KLRU Board of Directors on November 17, 2016.
