

RAFFLE RULES

Please Read the Terms and Conditions of Austin PBS's Beyond the Song event Raffle

TO ENTER

From August 18th through August 21st ("Entry Period"), entrants may enter Austin PBS's Raffle for the Beyond the Song event by completing the registration form which will include the purchaser's name, complete address, city, state, zip code, e-mail address, and telephone number. Purchase will also require a \$25 payment for 1 entry, \$100 payment for 5 entries, or \$250 for 15 entries.

SPONSOR

CONDITIONS

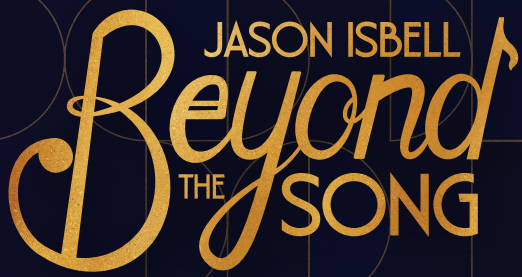
All eligible entrants may only enter via the ticket purchasing methods as described above. Incomplete entries are void. By entering, entrants acknowledge and affirm compliance with these official rules including all eligibility requirements. All entries become the property of the Sponsor and will not be returned. Neither Sponsor nor advertising and promotion agencies are responsible for incorrect or inaccurate transcription of entry information, or any other error or malfunction, or late, lost, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. No copies, facsimiles or reproductions of entries will be accepted.

DETERMINATION OF WINNER

A random drawing of a single ticket for each prize will be conducted on August 21st at the conclusion of the event from among all eligible entries received. Odds of winning depend upon the number of eligible entries received. The winner will be notified by announcement from the stage. The winner will be required to complete an affidavit of eligibility and release, which must be completed and returned within four (4) days of issuance of notification, or an alternate winner will be selected.
